One year ago we were concerned with citrus canker strain E and the effects on the fresh citrus fruit and overall citrus industry. This July the presence of citrus canker strain A (Asian strain) was confirmed in dooryard and commercial citrus plantings near the Florida west coast. The presence of this bacterial disease has resulted in the most severe regulations and destructive controls imposed on the citrus industry in the memory of virtually everyone in the citrus industry. The citrus canker state and federal regulators will be Packinghouse Newsletter No. 145

available during the afternoon equipment displays to answer questions about the current status of citrus canker and the resulting regulations.

Other concerns continue to be important, but receive less publicity. Topics on the Twenty-fifth Citrus Packinghouse Day program include fresh fruit trends, marketing, quarantine, citrus canker, machinery, fruit quality and decay control. These topics are also featured in the non-commercial afternoon equipment displays. The commercial displays are educational and the exhibitors expended a large effort for a short amount of your time. It is to your benefit to visit as many displays as possible after lunch.

Several important personnel changes have occurred in the last year. Please welcome Dr. Ed Echeverria as our newest faculty member in fresh fruit research, and Dr. Kalman Peleg as a visiting professor from Israel as he completes his sabbatical at Lake Alfred.
