#### THE PICKING PROBLEM

It isn't often that there is any good news with regard to harvesting labor, but an excellent review from California details the history of their picking problems, unionization hassles, etc. and reports a group (the Ventura County citrus industry) that has arrived at a surprisingly stable and mutually advantageous situation. (See Lloyd et al. in "Available Publications" below.)

Some quotations will give the general gist of this worthwhile publication:

"The Ventura lemon industry...demonstrates how employment stabilization can benefit both workers and employers."

"The packinghouses responded to Department of Labor and Union pressures by forming or joining harvesting associations..."

"The surprise feature of this story of fewer harvest workers, rising hourly earnings, and expanding fringe benefits is that growers' harvesting costs remained stable."

"The waiting list of applicants at Limoneira suggests that the best farm employers can hire legal workers, even if workers do not make harvesting lifetime careers."

The report concludes with the comment that the Ventura County citrus industry has been successful in developing legal "greencard" Mexicans as a stable labor force, but their U. S. raised children seldom want to pick fruit.
